- 一、 參賽即視為認同本活動之各項規定；不合規定者，主辦機關得逕行取消參賽與得獎資格。Participation in this contest constitutes full acknowledgment and acceptance of all official rules and regulations. The organizer reserves the right to disqualify any non-compliant entry and revoke any awarded prize.
- 二、 本人對於本活動規定及同意書之各項規定，無任何異議，並且無自行修改條文內容，否則視為放棄參賽權利。The Undersigned raises no objection to the contest rules and all terms of this agreement, and undertakes not to alter any clauses herein. Any unauthorized modification shall be deemed a forfeiture of participation rights.

- 三、 本人所提交之參賽作品，係出於本人之原始創作，並未公開發表或展出，絕無抄襲、仿冒、剽竊他人智慧財產權、未經同意拍攝侵害他人肖像權或其他侵害權利之情事，如有違反，本人願負相關之法律責任；如有以上情事發生，而取消本人（及本人團隊）參賽或得獎資格，本人願無條件歸還所領取之獎項及獎金。The Undersigned guarantees that the submitted work is an original creation that has not been publicly released or exhibited, and contains no plagiarism, counterfeit, misappropriation of intellectual property rights, unauthorized recording infringing on portrait/image rights, or violation of any third-party rights. In the event of any violation, the Undersigned shall assume all legal liabilities. If the Undersigned (or the entrant's team) is disqualified or has an award revoked due to such circumstances, all received prizes, certificates, and prize money shall be returned unconditionally.
